- 13) Council's Community Engagement Strategy Chris Grounds noted the Policy had passed at Council Meeting without much discussion. Disappointment felt but also hopefully future problems could be resolved as Strategy utilised.
- 14) **SGB Crematorium** Forum representative approached by local residents re new DA for crematorium, now moved from original highly valued environmentally diverse area with issues hard to overcome. - 18) **Regional Planning Panel** Discussions held re output of information form Regional Planning and Council. Community to be involved.
- 19) **Anson St** resident noted fencing around property approved for 2X4 storey buildings, possible construction site. SCC to ensure stormwater controls in place.
- 20) Councillor John Kotlash informed meeting that SCC CEO Stephen Dunshea has submitted resignation to commence in December. Vacancy for CEO.
