Community Strategy Plan. 2 sessions.

A sign on Princes Highway at Island Point Road turnoff, visible to traffic travelling north, <u>including</u> "Sanctuary Point" along with other villages names, is needed. Currently omitted.

## **Combined Regional CCBs**

At forthcoming meeting of these CCBs based around Bay & Basin area, the focus will on the LEP.

Large easily readable maps will be printed maps to see new & old zonings. One item requiring attention is proposed building height limit of 11 metres - becoming standard height. Other concern is 2C zones & mixed residential zones. Potential to impact upon rural areas & rural lifestyle. CCBs are lobbying for LEP to be advertised for minimum 12 weeks. Forum to get permission from Council to put maps their LEP related maps on our website.

Natural Resources & Floodplain Committee. Discussed at last meeting - Boating plan. The Regional Director of NSW Maritime had attended the meeting. Palm Beach and Blackett Park are 2 areas where there has been conflict between boating activities & swimmers. Users of these areas are urged report inappropriate or dangerous behaviour; record registration numbers.

Basin does have issue with craft speed. Observers need to record registration number, and how far out from shore.

Results from Council 'Survey Postcards'. The single most popular word was "fishing". The most popular activity was "passive recreation." Forum to invite Peter Dalmazzo - co-

ordinator of this initiative - to speak at Forum in 2010.
